- When exam results are published, and (some are) sent to universities and colleges by UCAS.
- There are four possible outcomes:





What is Clearing?

- A service that runs from 5 July 19 October <u>Find out more</u> about the key dates in the UCAS cycle
- To be eligible to use Clearing, applicants must have a live UCAS application and be in one of the following statuses:
 - applied before 30 June and has no offers
 - applied before 30 June and declined any offers received
 - did not meet the conditions of Firm or Insurance choice (and were unsuccessful at confirmation)
 - applied after 30 June (new application)

How Clearing works



How Clearing works

- Track confirms applicant eligibility and provides a Clearing number (six digits visible on the homepage).
- Applicants have a ten-digit Personal ID (PID) and should be able to quote both.
- Adviser portal displays in real time, updates are suspended in <u>embargo</u> periods.
- On A level results day, the 'Add Clearing choice' button appears from 14:00 (UK time) for eligible applicants.



Clearing is more popular than ever


 Clearing has been changing – rather than be used purely as a plan B, it's now a credible way for students to get into higher education.

In 2020, 88,370 students placed via clearing.

 In 2020 for the first time, unplaced students were matched to courses available in Clearing through <u>Clearing Plus</u>. Increasing the personalised options and support available to students.










Decline my place

- Available from 5 July
- Placed applicants can select
 'Decline my place'.
- Applicants should only use this if they no longer wish to take up their place at their firm choice.

Adjustment

- Adjustment is an opportunity to find an alternative course if an applicant has met and exceeded the conditions of their conditional firm choice.
- It is available from A level results (10 August) day to 18 August.
- Applicants needs to register to use it via Track then have 5 x 24 (inc. weekends) hour periods to adjust.
- The gaining provider will adjust the UCAS application, the applicant doesn't do anything on Track once they have registered.
- It is only used by a small number of students 270 in 2020

Students no longer get an AS12 letter in Track. The embargo period for 2021 is 4 August at 12:00 until 10 August at 08:30. Clearing choice can be added from 14.00 on August 10.
